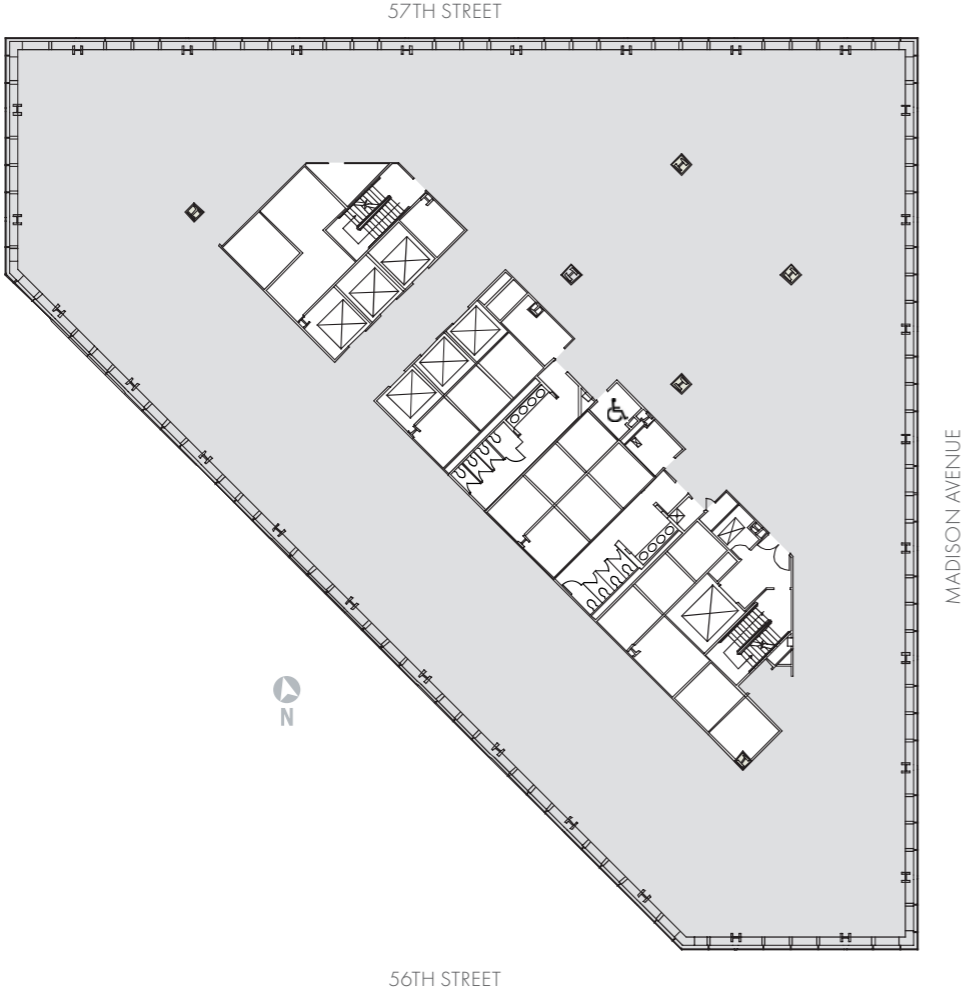


590 MADISON AVENUE | EFFICIENT & FLEXIBLE FLOORPLAN

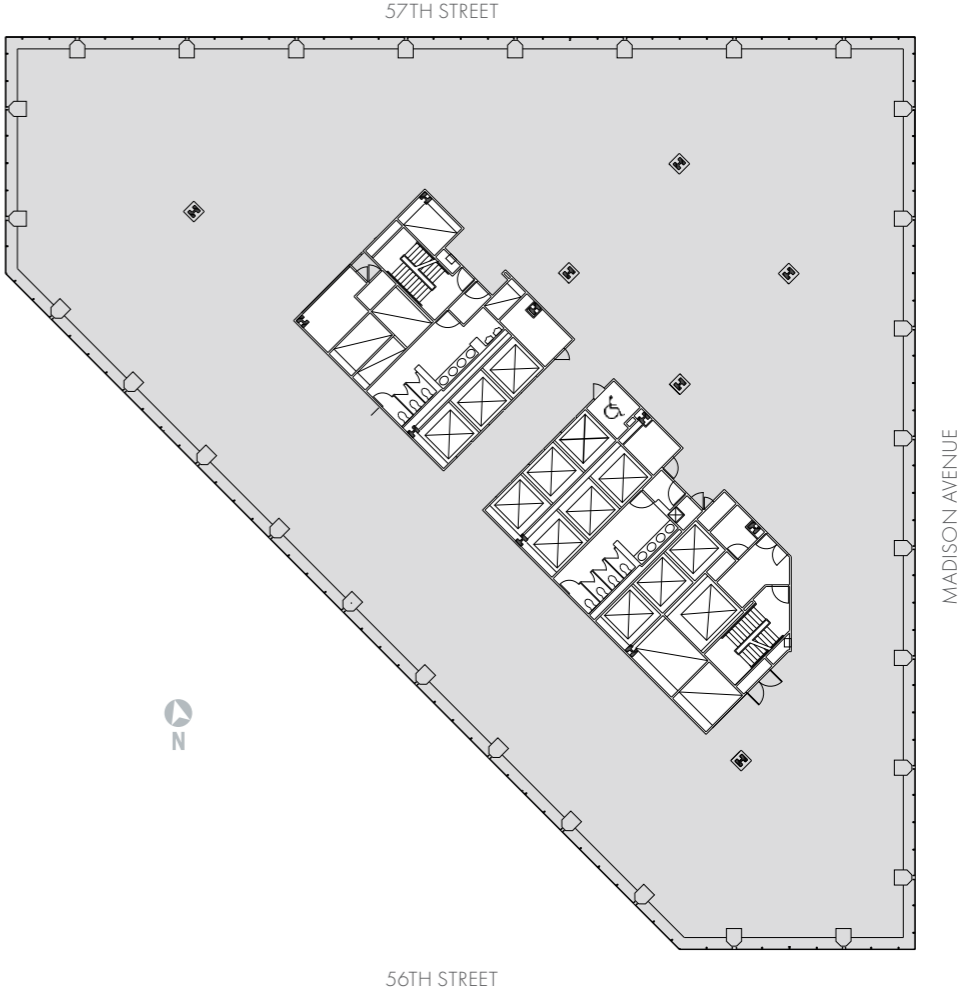
LOWRISE CORE PLAN (FLOORS 9-17)

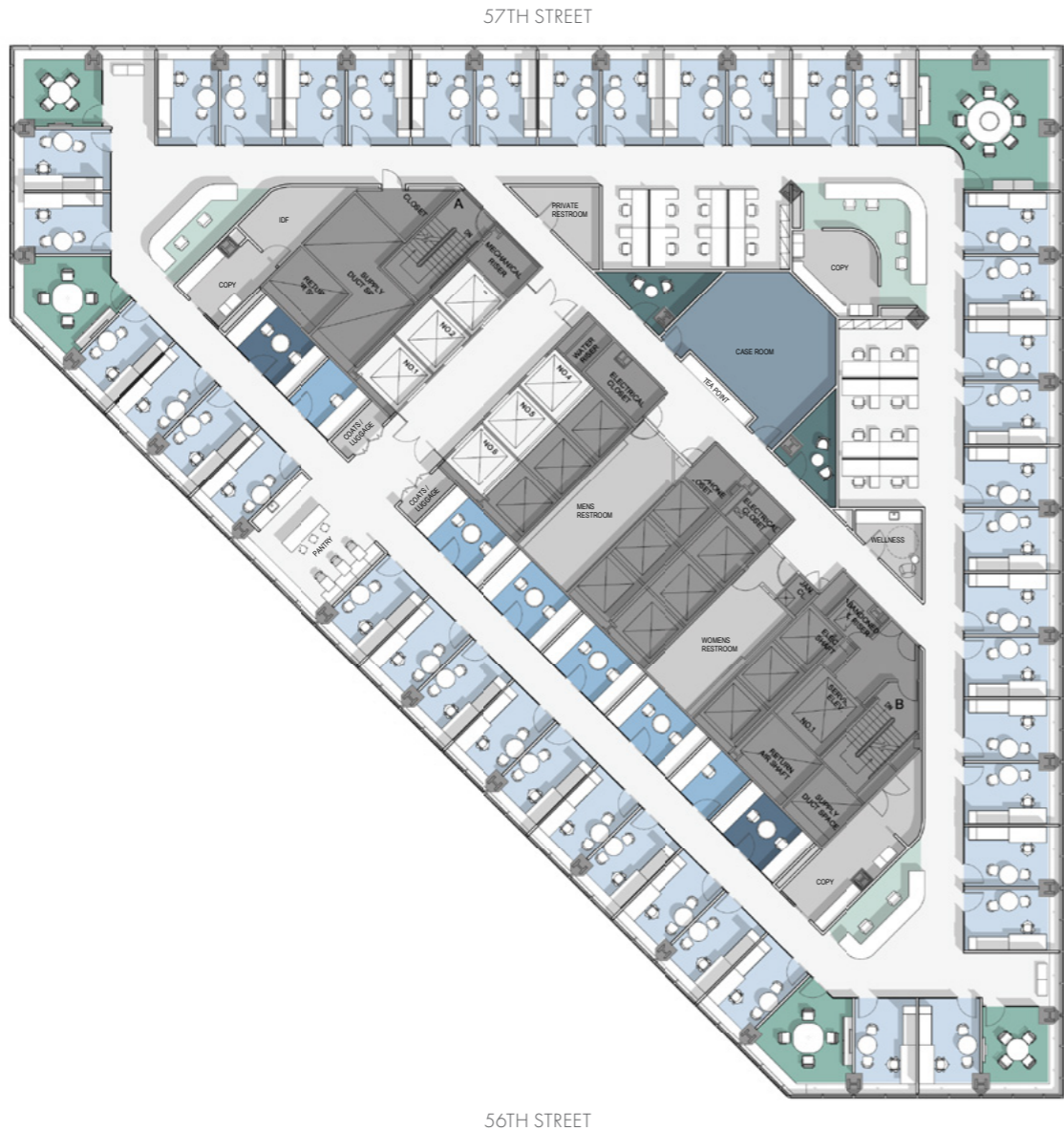

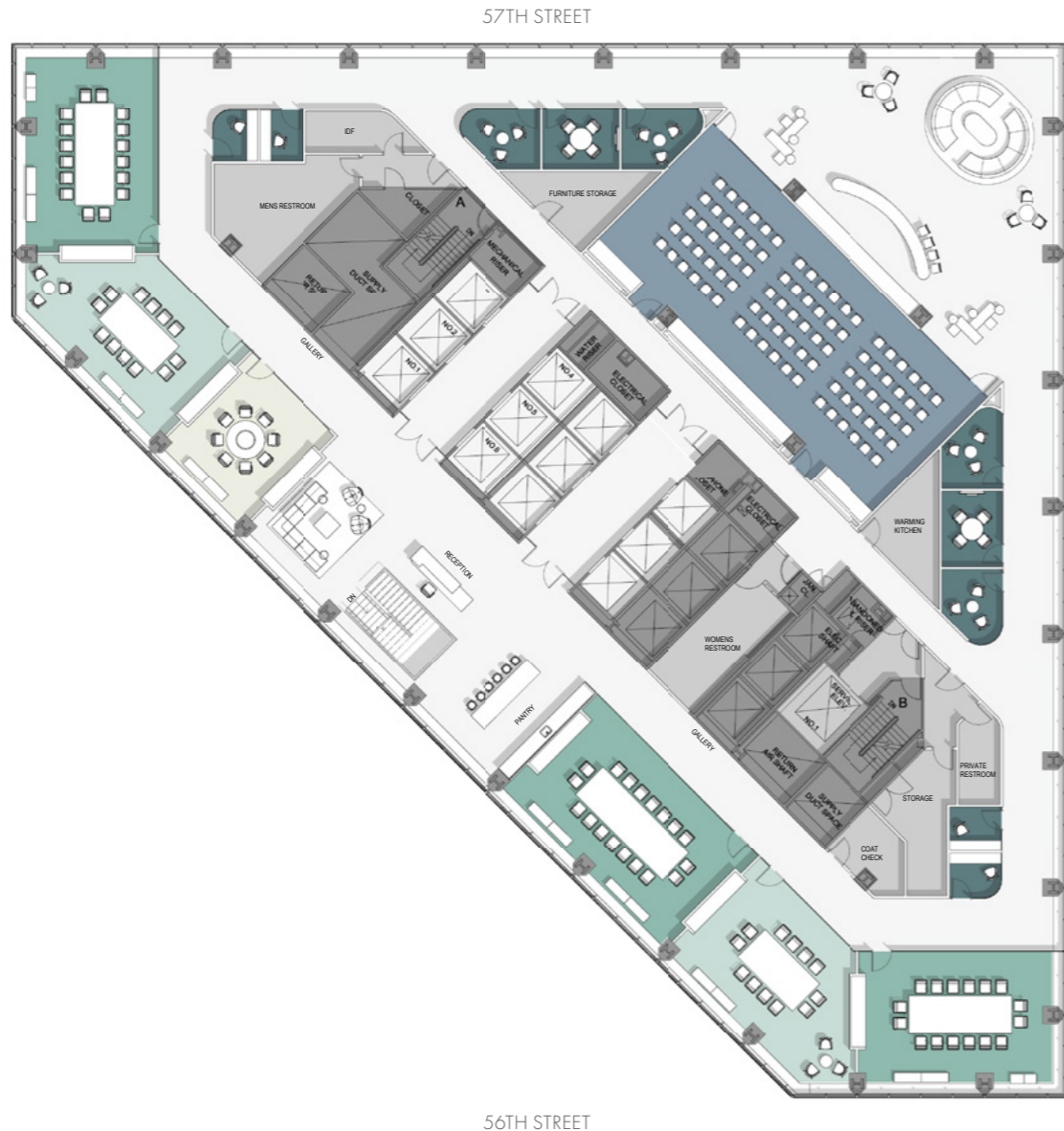
